**Fee: \$400.00 per student**

**This is a great camp for riders who have advanced to cantering and want a review to polish up their equitation skills on the flat and want to advance to beginning equitation ( 18" and less ) over the fences.**

**This is the basic preparation camp for winning at horse shows.**

**Since the judging criteria covers the rider's performance and control of the horse, use of riding aids, proper attire, correct form, you will learn rider poise, the cleanliness and polish of horse, rider and equipment.**

**Here, you will learn how a good equitation rider is always in balance with the horse, maintains a correct position in every gait, movement, or over a fence, and possesses a commanding, but relaxed, presence, able to direct the horse with nearly invisible aids.**

**How to Enroll:**

This packet contains the following documents required for each camp participant. These are required to ensure a safe and fun experience for your camper.

- Enrollment Agreement
- Medical Information Form
- Release of Liability Form

Complete the above forms:

A separate Enrollment Agreement form must be used for each camper and session.

Deposits:

**To ensure successful enrollment**, a **non-refundable \$200.00** deposit must be received at our office two weeks prior to the beginning of camp. Please keep in mind that we process enrollments, on a "First come, First serve" basis. Your early deposit will ensure your spot..

Telephone enrollments are accepted with your VISA or Master Charge debit or credit card

**The remaining \$200.00 balance is due the first day of camp.**

There is a \$45.00 return check fee regardless of reason.

Refunds:

The deposit is non refundable, unless a written doctor's explanation of why your child can not attend camp is provided.

Drop off and pick up times:

All camp sessions begin at 8:30am. Campers should arrive 15 to 30 minutes prior to start of camp and should be picked up no later than 30 minutes after the end of camp session.

We do provide for after-camp care for an additional \$10.00 per hour. Children utilizing after-camp care will need to be picked up no later than 3:00 pm.

Emergencies, sickness or injuries:

A medical form is required so that emergency contact procedures are in place. This will facilitate notifying emergency response personnel as well as parents/guardians listed on the medical form.

What to bring:

**Riding boots** (something with an inch to an inch and a half heel and ankle support)

**A certified horseback riding helmet** (We have helmets for loan - no charge)

**Riding Breeches/Jeans**

**Shorts** (To change into after riding)

**Any prescription medications**

**Hair tie/Hat**

**Sun screen**

**Clothing to ensure campers comfort**

**A bagged lunch everyday except Friday**

**PLENTY of drinking fluids**, there is a refrigerator at the Farm.

Special treats will be provided throughout the week.  
Please inform us at registration if there are any dietary restrictions for your camper.

### Parents and campers agreement

---

By signing this form we acknowledge that we have read and agree to the following conditions of enrollment:

It is understood that no refund or reduction of tuition will be made for the withdrawal of camper for the following reasons:

- Late arrival
- Early departure
- Dismissal for misconduct including: homesickness, physical or behavioral problems.

In the event of accident or illness, at the sole discretion of Wrangler Farms, with exception to the non-refundable deposit, a 50% pro-rata refund may be made to the parent/guardian.

It is understood that the parent/guardian of campers are obligated to inform Wrangler Farms at the time of application, if the child has or has had any physical or behavioral problems that have required professional

treatment. Wrangler Farms may decline enrollment to said child, or may revoke such acceptance, when it is apparent the child may not have a successful camp experience or may cause other campers not to have a successful camp experience. The parent/guardian agrees to remove child from the camp upon notification of child exhibiting emotional, behavioral or psychological conditions, which are disruptive to the camp program or harmful to the child without refund of fee.

While problems of the following nature are rare, our policy is to dismiss campers without refund for reasons including but not limited to the following: use or possession of chemical substances, cigarettes, chewing tobacco, illegal drugs, persistent inappropriate language, conduct which is dangerous, illegal or in the opinion of Wrangler Farms detrimental to the camp and/or other campers.

# Assumption of Risk and Responsibility Release of Liability Form

Acknowledgement of Risks: Parent/Guardian/Student hereby acknowledges that he/she has the full and complete notice and understanding of all risks inherent in equine activities which may cause, contribute to or result in death or personal injury of the participant or damage to the participant's property (the "risks" including but not necessarily limited to the following:

I realize that there is an inherent danger in the use of any horse with or without saddle.

Equines are known to behave in dangerous ways or to trip or fall.

There is an Inability to predict an Equine's reaction to movement, objects, persons, other equines, excitement, weather conditions, all types of creatures and the effects of such reactions

The hazards of surface or subsurface conditions including objects or conditions on, under or protruding from the surface whether apparent or not.

The hazards presented by rocks, cliffs, hills, fences, trees, stumps, logs, bridges, ditches and other debris and /or obstacles. Weather can create slippery conditions associated with fog, rain, sleet, ice or snow.

The dangers and risk of tack, equipment, or harness slipping or breaking

The dangers and risks of becoming entangled in tack, equipment or harness or any vehicle used in and animal activity.

The risks of falling from or otherwise becoming unsteady on an equine vehicle used in any equine activity or for any reason whatsoever. The parent/guardian/student acknowledges that riding an equine is a high risk sport and that he/she is participating at his/her own risk.

**Assumption of Risk and Responsibility:** In recognition of the inherent risks of the activity, which I and any minor children for which I am responsible, and will engage in, including the following:

Approaching, handling, mounting, riding and dismounting a saddle animal, I confirm that I am (we are) physically and mentally capable of participating in the activity and using the equipment. I/WE participate willingly and voluntarily and I assume full responsibility for personal injury, accidents, illness or death. I assume all responsibility for damage to or loss of personal property as a result of any accident that may occur. This risk may include but not limited to the following:

Sprains, torn muscles and or ligaments, fractured or broken bones, eye damage, cuts, wounds, scrapes,, abrasions, and or contusions, dehydration, oxygen shortage, exposure and or altitude sickness, head, neck or spinal injuries, animal bites or attacks, insect bites, allergic reactions, shock, paralysis or death. I/We also acknowledge that if during the activity I/We experience fatigue, chill, dizziness my/our reaction time may be diminished and the risk of an accident, increased.

That a wearing of a helmet is a basic precaution and that he/she should ask about other potential risks, dangers and hazard and recommended precautions and procedures.

Good Faith: I/We accept the fact that Wrangler Farms will operate under a covenant of good faith and fair dealings, but that Wrangler Farms may find it necessary to terminate an activity due to forces of nature, medical necessities or other [problems. I/We accept the right of Wrangler to take such actions for the safety of myself and other participants.

Authorization: I hereby authorize any medical treatment deemed necessary in the event of any injury while participating in the activity. I either have appropriate insurance or, in its absence, agree to pay all costs of rescue and or medical services as maybe incurred on my/our behalf.

Release: Parent/Guardian/Student, heirs, personal representatives or assigns do hereby release Wrangler Farms,LLC, its principals, directors, officers, agents, employees and volunteers and each and every land owner, municipal and or government agency upon whose property an activity is conducted, from all liability and waive any claim for damage arising from any cause whatsoever.

Warning: equine activity sponsors and equine professionals are not liable for injury to or death of a participant arising out of riding, training, driving, grooming or riding as a passenger upon an equine: including rides, trips and hunt however informal or impromptu and whether or not a fee is paid to participate in the activity.
